Lithium batteries are dangerous goods, and all of the regulatory requirements must be complied with, as set out in the Lithium Battery Shipping Regulations.

# Can lithium ion batteries be shipped in bulk?

Standalone lithium batteries can ship in bulk via cargo aircraftbut they must be packed in an approved way to prevent short circuits. That includes individually packaging batteries and placing the batteries in a secondary outer packaging, which is also designed to prevent short circuits. Is it difficult to book shipments of lithium ion batteries?

### Can EV batteries be shipped internationally?

Yes. But because of the type and weight of the batteries and the significant restrictions shipping by air,ocean freight is the dominant mode for shipping lithium-ion batteries internationally,including EV batteries. Standalone lithium batteries are prohibited to transport as cargo on passenger flights.
