Are customer complaints a problem in the solar industry?

Customer complaints against the country's residential rooftop solar industry have increased dramatically in recent years. One-star ratings on Solar Reviews increased more than 1,000% since 2018. Can utilities be liable if they attack rooftop solar?

"For the first time,a federal court has said utilities can be liableunder antitrust laws if they attack rooftop solar," Su said. "The future for renewable energy just got a light brighter." An SRP spokesman said the ruling was at least a partial victory with certain claims having been dismissed.

Why is Minnesota suing a solar loan company?
