Does Saint Lucia have a tax on electric vehicles?

In 2014 The Government of Saint Lucia (GOSL), through a Cabinet Conclusion, granted a reduction of import duties on electric vehicles: "Duties and taxes on hybrid vehicles and vehicles that allow operation on Sustainable fuels". This provided an incentive for the use of sustainably-fueled vehicles on island.

Does Saint Lucia import energy?

Like most SIDS, Saint Lucia is a net importer of energy and currently imports about 98% of its overall energy supply. Final Consumption is dominated by the Electricity and Transport sectors. High dependency on fossil fuels imports make the country vulnerable to external factors such as fluctuations in the world oil market.
