How many shipments of solar energy equipment have been seized?

U.S. Customs and Border Protection has seized 1,053 shipments of solar energy equipment between June 21, when the Uyghur Forced Labor Protection Act went into effect, and Oct. 25, it told Reuters in response to a public records request, adding none of the shipments have yet been released.

Are solar panels stolen?

The theft of solar panels is becoming more of a regular occurrence Worldwide, with people losing tens of thousands in equipment. Solar panels are valuable, and anything valuable within our society can be a target for thieves.

Why did solar projects slow in the third quarter?

Solar installations in the United States slowed by 23% in the third quarter, and nearly 23 gigawatts of solar projects are delayed, largely due to an inability to obtain panels, according to the American Clean Power Association trade group. ACP urged the Biden administration to streamline the vetting process for imports.

How many solar shipments has CBP detained under uflpa?

CBP has previously said that it had detained about 1,700shipments worth \$516.3 million under UFLPA through September but has never before detailed how many of those shipments contained solar equipment. The EU has also proposed a ban on products from Xinjiang but has not implemented one.

Who makes solar panels in China?

Three industry sources with knowledge of the matter, however, told Reuters the detained products include panels and polysilicon cells likely amounting to up to 1 gigawatt of capacity and primarily made by three Chinese manufacturers - Longi Green Energy Technology Co Ltd(601012.SS), Trina Solar Co Ltd (688599.SS) and JinkoSolar Holding Co (JKS.N).
