

Are lithium ion batteries taxable?

The government, however, exempted import of parts, sub-parts and raw material used in making lithium-ion cells from the customs duty. There is, however, no change in the basic customs duty on import of lithium-ion battery for cellular mobile phones, which remains taxable at 15%.

What is the tariff rate on lithium ion batteries?

In a Fact Sheet issued by the White House today (14 May), the Administration said it would increase the tariff rate on lithium-ion batteries for electric vehicles (EVs) from 7.5% to 25% in 2024, and the tariff rate for non-EV lithium-ion batteries from 7.5% to 25% in 2026.

What are China's new import taxes on lithium ion batteries?

This includes the removal of import taxes on lithium chloride, lithium carbonate, nickel sulphate, and cobalt carbonate, all previously set at 5%. Additionally, China eliminated the 3% import tax on low-arsenic fluoride, a crucial material for electrolyte production in lithium-ion batteries.
